**TERMS & CONDITIONS:**

1. The tenderer shall thoroughly acquaint himself with the working conditions, nature of work, specifications and other conditions, facilities available at site. For clarification if any with regard to the tender documents etc. the Assistant Executive Director-II (Estate) may be contacted before quoting the rates on any working days (Monday to Friday) between 10:00 am to 5:00 pm.
2. Income tax/TDS shall be deducted from each running account bill as per Govt. Rules & Regulations. A photocopy of **PAN card** allotted by the income Tax Department should be attached with tender.
3. The contracting firm should be registered with trade tax department and have valid GSTIN number. A copy of **GSTIN registration number** should be attached with tender.
4. The firm should registered with state/central Govt. departments such as state **PWD/CPWD/MTNL/MES/DDA/BSNL** or any other statuary body of the Government (Centre/state) with valid registration number with requisite work experience. A copy of company/ firm registration number along with award letter and completion/ execution certificate should be attached with the tender.
5. The firm should have average Annual financial turnover during the last three years, ending on 31<sup>st</sup> March of the previous financial year, should be at least 3.50 Lakhs. A copy of **audited balance sheet & P/L account statement** should be attached with tender.
6. The bidder shall have to submit **Power of Attorney** signed by all directors/partners/proprietor.
7. Initially, the contract period shall be of Twelve (12) months. This can be extended up to two years on yearly basis). That will be based on the satisfactory services provided during the previous year contract and mutual consent of both the parties on same rates, terms & conditions and 5% increase on tendered rates in every extension of one year, if the Academy is satisfied with the services provided by the party in previous tenure.
8. **Penalty:** If any breakdown occurred for more than 24 hours, the contractor will be charged Rs. 500/- per day for 5 KVA UPS, Rs. 750/- per day for 15 KVA UPS and Rs. 1000/- per day for 30 KVA UPS.
9. **Loss / Damage:**
  - a) Any loss or damage or injury to the contractor's employees/ workmen shall be entirely at contractor's risk & cost and the INSA shall in no way be liable for the same.
  - b) The INSA shall not be liable for any consequent loss or damages whatsoever to contractor during the currency of the work.

c) In case of any loss or damage to the property of INSA or injury to the life and or its employees/ or property/ life of third party shall be compensated by the contractor if the cause of such loss or damage be on account of default, negligence or lapse of contractor and /or his employees.

10. Contractor shall follow all safety measures and it shall be his sole responsibility to meet all safety requirements.

11. The tender will remain valid for 90 days from the date of opening for the purpose of acceptance of tender and award of contract. The validity of tender beyond four week from the date of opening may be extended further with the mutual consent of both the parties if required.

18. The party will provide additional UPS of specifications as mentioned in the tender document, if demanded by the Academy in addition to the quantity & capacity of the UPS.
19. The quantity of UPS mentioned in tender document may increase or decrease at any time during the currency of contract. It will depend upon the site condition & requirement(s).
20. The estimated cost for the work is Rs. 9,98,280/- (Rupees Nine Lakhs Ninety Eight Thousand Two Hundred Eighty only) including GST@ 18 %. This estimated value is based on the prevailing market rates.

32. In case the amount in figure and word vary, the amount quoted in words will be accepted.

The successful bidder will also check the batteries for their peak performance during their visit and replace them free of cost, if needed.

In case of any break down, UPS will be attended by the supplying Agency's Engineer within four hours of reporting the same by INSA and complaint should be attended by the contractor on the same day. In any case, if complaint prolongs, a standby UPS will be provided by the agency free of cost to INSA.

The contractor will replace any or all batteries which will be damaged or defective, free of cost in case of any failure of batteries. In case of break-down spare parts whichever is required, will be supplied by the contractor free of cost.
